





#### TOURNAMENT RULES & REGULATIONS

**REGISTRATION**: Teams may register by mailing entry forms and checks to Dylan Fuller @ 933 Dady Road, McEwen TN 37101 (Make checks to Flood Victim Benefit Tournament). Teams may also register by e-mailing the entry form to dylan.fuller@mlec.com and paying via PayPal: @FloodVictimBenefit or Venmo: @FloodVictim-Benefit-Tournament Boat numbers will be assigned by order of entry.









- combustion engine is running. Each angler is required to wear a fastened, U.S. Coast Guard approved, P.F.D. anytime the combustion engine is running.
- BOAT & HORSEPOWER REGULATIONS: Boats must have all required U.S. Coast Guard safety equipment. Boats must have adequate livewell space & aerators to maintain a limit of fish alive. Horsepower must not exceed what is set forth

by the U.S Coast Guard and/or the boat manufacturer. **PERMITTED FISHING LOCATIONS:** Anglers may fish anywhere on tournament waters available to the public and accessible by boat, except areas designated as "off-limits" or "no fishing" by local, state, or federal officials.

- **OFFICIAL CHECKPOINTS:** Failure to go through morning livewell check or your designated time check-in point in the afternoon will result in penalties or disgualification. All fishing must cease upon check-in.
- 8. LATE PENALTY: Penalty of 1 pound for every minute you are late to your designated check-in time. Any contestants more than 15 minutes late will be disgualified.
  - SCORING: Only spotted, largemouth, & smallmouth bass will be weighed. Limit will be 5 fish - 15" on all species, measured on a Golden Rule board with mouth closed. A penalty of 8 ounces will be deducted for each dead fish. Short fish will be thrown out. & penalized 1 pound from total weight.
- WEIGH-IN: After your designated check-in time at the ramp, anglers will trailer 10. their boats while keeping their water and fish in livewell and immediately proceed to the designated weigh-in area at the JERA Park. There will be helpers and signs to show the way. Teams must use our weigh-in bags.
- TIEBREAKERS: Most fish weighed, most live fish weighed, earliest entry.
- POLYGRAPHS & PROTESTS: All contestants are subject to a polygraph. All protests must be submitted in writing within 10 minutes of the scales being closed. Artificial baits only, with the exception of pork trailers. Trolling is not permitted. All bass must be caught alive in a conventional manner.
